Application are invited to attend Interview (in-person / online through video conferencing) for the post of Junior Research Fellow or Proejct Associate-II or Project Associate-I under Following, Government funded project up to September, 2024(Anthrax) & upto (Hi Edit) Dec 2025 or co-terminus of project whichever is earlier on purely contractual basis at ICAR-DOGR, Pune as mentioned below.

Owing to the prevailing COVID-19 crisis, candidate may choose for interview either in person or through online process. The eligible candidates (appearing in-person as well as online mode) are requested to send their duly filled application in the enclosed Application form along with complete scanned copy of the original documents only through email in one time to <u>recruitment.dogr@icar.gov.in</u> on or before 06.05.2023. Application received after due date will not be considered for screening. After screening the applications, the eligible candidates will be informed by email or over phone and on website of ICAR-DOGR (<u>https://dogr.icar.gov.in</u>) for further details regarding interview. Original documents of the candidates appearing interview in-person will be verified on the date of interview and for the candidates appearing online interview will be verified at a later stage.

The interview will be conducted by personal appearance at ICAR-DOGR, Pune or through video conferencing. The candidate may appear for the interview personally, if allowed by the Government Authorities. ICAR-DOGR will not be responsible if any candidate is not allowed by the authorities to attend the interview.

Terms and conditions:

- 1. The interview for the above posts will be conducted through in- person at ICAR DOGR, Pune/ online through video conferencing (Scheduled date & time which will be intimated later on through phone/email/whatsApp or uploaded on Directorate's website <u>https://dogr.icar.gov.in</u>).
- 2. The interview will be conducted by strictly following COVID 19 guidelines given by Maharashtra state government / Government of India. All the candidates should follow the COVID 19 guidelines as such, if any deviation will not be allowed to attend the interview. No candidates will be allowed to enter ICAR-DOGR campus without mask.
- 3. Only Indian citizens are eligible for appearing in the online interview/ in-person interview.
- 4. Candidate may choose the option of interview either in-person or online video conferencing.
- 5. Age limit: Maximum age is 35 years for men and 40 years for women as on last date of submission of application through email.
- 6. Period of contract service Up to 28<sup>th</sup>September, 2024 & Dec. 2025 or co-terminus of project whichever is earlier
- 7. The above positions are purely temporary basis and co terminus with the project subject to satisfactory performance. The selected candidates shall have no right/claim for regular appointment or absorption at ICAR-DOGR at any point of time.
- 8. No TA/DA and official accommodations will be paid /provided for appearing in the interview.
- 9. Only the candidates having essential qualification will only be considered for interview.
- 10. Candidates are requested to ensure their eligibility like age, qualification etc. before appearing for the interview.
- 11. Concealing of facts or canvassing in any form shall lead to cancellation of candidature or termination.
- 12. Person already in employment should submit "No objection Certificate" from their present employer.
- 13. The selected candidates will be stationed at Pune or at project sites as required from time to time and may have to conduct extensive field work involving frequent travel, laboratory works and survey of different sites for sample collection as and when required.
- 14. The eligible candidates (appearing for interview in-person / online video conferencing) are requested to send their duly filled scanned copy of Application Form affixing a passport size photograph on the top and declaration duly signed in the application form annexed with duly self-attested all supporting documents/ certificates such as (Proof for age, Category certificate, educational qualifications Mark sheets & certificates from 10<sup>th</sup> class onwards, certificate of NET or other national level exams, experience and research publication) only through email to <u>recruitment.dogr@icar.gov.in</u> on or before 06.05.2023
- 15. Application should be submitted by the candidates in the prescribe Proforma only. The entire desired document should be attached in the sequence as given in check list and check list should be duly filled as per given table in the application form. Applications if not found in proper Proforma along with desired documents as per check list may likely to be rejected.
- 16. Weightage of marks for selection: For scrutiny or short listing of the candidates, it will be based on academic qualifications where maximum marks will be 50 and for interview maximum marks will be 50. Final selection will be based on marks of both academic as well as interview marks.
- 17. List of the candidates who are eligible for (in-person / online through video conferencing) interview will be published on Directorates website <u>https://dogr.icar.gov.in</u> and will also be informed through email/ phone/WhatsApp. Candidates are requested to provide email, phone & WhatsApp number in application.

- 18. All eligible candidates are requested to be present 60 minutes before reporting time on the date of in-person interview for necessary formalities and verification of documents.
- 19. Original documents of the candidates appearing interview in-person will be verified on the date of interview and for the candidates appearing online interview it will be verified at later stage of the selected candidates only before joining. If found incorrect his/her candidature will be cancelled.
- 20. Selected Candidates (s) will be required to produce all original documents at the time of Joining for verification purpose.
- 21. The selected candidate will be required to produce medical certificate at the time of joining.
- 22. The Director reserves the right to cancel/postpone the interview without assigning any reason thereof.
