The details of the eligible and not eligible candidates along with the reasons(s) of the rejection of their candidatures are mentioned as referred above. As per the recommendations of the Screening Committees, the eligibility of the candidates would continue to be provisional subject to final verification of the documents/ certificate etc., before appointment. If it is detected by the Directorate at any point of time in future that the academic credentials and other relevant documents as submitted by the candidate are not genuine or the candidate was not eligible for the contractual post as per the prescribed educational qualifications and experience etc., which could not be detected during the screening process due to whatever circumstances, the candidature of the concerned candidate shall be liable to cancel as per rule. Accordingly, all the candidates are required to go through the recommendations of the Screening committees.

If any candidate is aggrieved by the reason(s) of non-eligibility provided in the enclosed list, he/she may bring his/her objection in the cognizance of Directorate by clearly specifying the reason of such objection and by enclosing supporting documents via e-mail to be addressed to [recruitment.dogr@icar.gov.in](mailto:recruitment.dogr@icar.gov.in) latest by **31.05.2024**. No query in this regard shall be entertained after the mentioned date and time in any case and the list of not eligible candidates will be treated as final. Anomaly if any, shall be rectified as per rule.

**However, mere submission of objection/representation will not confer any right/claim in favor of his/her candidature for being short listed/eligible.** The utmost attention shall be paid to the justification provided by the candidate. However, the decision of the Directorate Authority shall be final and binding to the candidate.

**Kind Attention:**

1. A Not eligible candidate cannot participate in subsequent rounds of selection.
2. No separate communication to the candidate is being sent. Utmost care has been taken while screening the candidate's application before declaring them not eligible.

**Note: Applicant whose name is not appearing in any of the list of Eligible /Not eligible candidates means either their application has been received after due date or not received at all through E-mail.**
